The posters will be on display on Saturday during lunch from 11:45 am – 12:30 pm. Posters will be setup on Saturday morning. Check in at the registration desk with your poster.

### **INSTRUCTIONS FOR COMPLETION OF ABSTRACT**

1. Abstracts must be typed, single-spaced, within the frame of the form provided below.
2. Avoid abbreviations where possible.
3. Abstract should include, in the following order and on separate lines:
  - a. Title (type in Bold Lower Case, capitalize when appropriate)
  - b. Author(s) Name(s) – please underline the name of the presenter(s)
  - c. Institutions name including city and state
  - d. Abstract Text should be single-spaced, indent all paragraphs, type within the lines of the box. The font to be used throughout is 11 point Times New Roman. Sections of the abstract text should include: a Purpose, Methods, Results, and Conclusions.
  - e. The abstract should not include tables or graphs.
4. Instructions for submission

#### HOW TO PREPARE A POSTER FOR PRESENTATION

1. Create a banner at the top of the poster with the poster title and author(s) and the health system name.
2. Prepare a written summary of your project. Organize the poster sections as follows:
  - a. **Objective(s)/Purpose** of the study or project
  - b. **Methods** used in the study or project
  - c. **Results** of the study or project
  - d. **Conclusions/Evaluation** of the study or project.
  - e. **Author disclosure panel**
3. Poster format should be: Laminated “roll-up” poster which could be affixed to wall-space at the meeting site location (suggested **maximum** size would be a height of 36” and width of 48”)
  - a. The use of projector or demonstration equipment of any kind is not allowed.
  - b. No Velcro, tape, or staples are allowed on the poster boards.
  - c. Bring your own push pins.
  - d. Posters made of heavy laminated materials usually take more than one person and require many push pins to hang. Please consider lighter weight materials.
